**ORDER**

**THIS APPLICATION**, made by the Applicant, the College of Traditional Chinese Medicine Practitioners and Acupuncturists of Ontario (the “College”), for declarations that Sherry X. Yin a.k.a. Xueping Yin (“Ms. Yin”) has violated the *Regulated Health Professions Act, 1991*, S.O. 1991, c. 18 (the “*RHPA*”) and the *Traditional Chinese Medicine Act, 2008*, S.O. 2008, c. 27 (the “*TCMA*”) and for an interim and interlocutory and permanent injunction against Ms. Yin, was heard this day at the Court House, 393 University Avenue, Toronto, Ontario, M5G 1E6.

ON READING the Applicant's Application Record, Factum, and Brief of Authorities, and on hearing the submissions of counsel for the College and the Respondent, attending in person:

1. **THIS COURT ORDERS** that the Application be and hereby is adjourned to August 5, 2015, pre-emptory on the Respondent, and upon the terms below.


2. **THIS COURT FURTHER ORDERS** that the Respondent shall, until final adjudication of this Application, immediately cease and desist:

- (a) using the title "doctor", or any abbreviation thereto;
- (b) using the titles "traditional Chinese medicine practitioner" or "acupuncturist", or any variation thereof;
- (c) holding herself out as a person who is qualified to practice in Ontario as a traditional Chinese medicine practitioner or acupuncturist;
- (d) performing controlled acts limited to members of the College; and
- (e) advising persons with respect to their health in circumstances in which it is reasonably foreseeable that serious harm may result from treatment or advice or from an omission from them; and

3. **THIS COURT ORDERS** that the costs of today's appearance are reserved to the Judge hearing the Application.
