ORDER FOR PUBLICATION AND BROADCASTING BAN

THE HEARING PANEL HEREBY ORDERS that no person shall publish, broadcast or otherwise disclose the name of the patients (both identified as the "Patient" in the Notices of Hearing dated November 16, 2022) referred to during the hearing or in documents filed at the hearing commencing on February 5, 2024 or any information that would disclose the identity of the patients.

Counsel for the College of Traditional Chinese Medicine Practitioners and Acupuncturists of Ontario (the "College") brought a motion on consent pursuant to s 45(3) of the Health Professions Procedural Code being Schedule 2 to the *Regulated Health Professions Act, 1991*, SO 1991, c 18, for an order banning the publication, broadcasting or disclosure of the name of the patients and/or any information that would disclose the identity of the patients referred to during the hearing or in documents filed at the hearing commencing on February 5, 2024.

Upon hearing the submissions of counsel for the College and the former member, Chanpheng Anousaya, with respect to the motion, the Panel's reasons for granting the motion are:

- financial or personal or other matters, including the patients' personal health information, may be disclosed at the hearing of such a nature that the harm created by disclosing the identity of the patients would outweigh the desirability of adhering to the principle that hearings be open to the public.
